The deadline for application submissions for candidates for President and Treasurer is May 22<sup>nd</sup>, 2023. The deadline for application submissions for candidates for Continental Representatives is June 22<sup>nd</sup>, 2023.

**NOTE that Continental Representatives, although they are put forward by the relevant Continental Organization, are still required to fill out this application submission form and provide the relevant documentation.**
